The followings are simple steps to help guide you through how to donate money online to help our wounded soldiers. Thank you for your participation. --*bkt*






Instruction How to use this web page to interface with *PayPal*


Our official name (*legal name*) is **Family of the Vietnamese Red Berets Corporation**. Abbreviated as **FOTVRBC**. This name is registered with state of Virginia Council for Corporations since 2006.

The followings are steps involve in *donating money online* via *PayPal* to help our ARVN wounded soldiers who still live in Vietnam. Each instruction is numbered in RED. Please follow figures 1-5 below for more details.

1. This symbol  presented above is placed at the end of this web page. If you are already familiar with the *PayPal* process, you may [head straight to the PayPal process](#). Otherwise, follow steps below.

Instruction: Whenever you click once at the  button, you will leave this page and land on the online *PayPal* page as depicted in Figure 2 below. **Note:** *you should pay attention only to the RED fingers presented on this instruction set with number on them. These RED hands belong to this page, they will not be found on PayPal pages.*

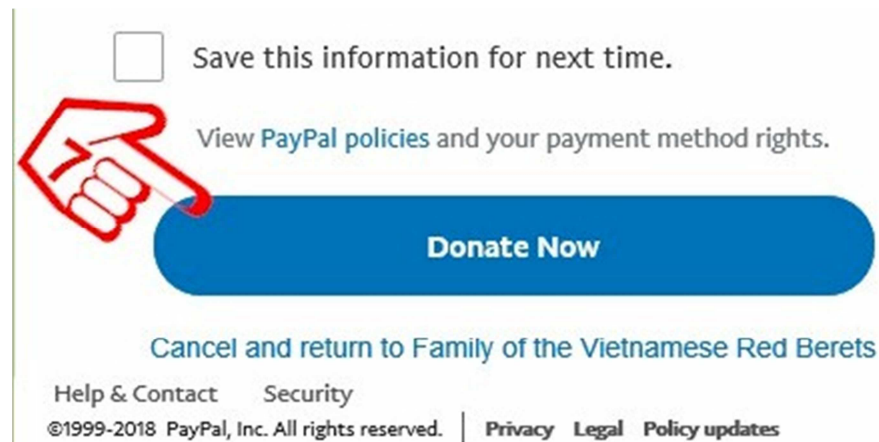


